PROFESSIONAL BACKGROUND

Mr. McLauchlan joined Lord Bissell & Brook LLP as an Associate upon graduating from law school. In 1980, he was elected an Equity Partner and became one of the firm's top litigators. McLauchlan P.C. joined two of his former LBB partners as a partner in the firm of Lindemann Miller & Siderius LLP, a boutique firm specializing in insurance legal issues, where he focused on complex reinsurance litigation, mediation, arbitration and business counseling.

In January, 2009, he founded The McLauchlan Law Group LLC, and The International Arbitration & Mediation Group LLC serving as the Managing Partner. Since that time he has served as general outside counsel for numerous small and medium sized businesses and continued his work in the field of dispute resolution through mediation, arbitration and business litigation.
